A motion made by Summers and seconded by Loxley was passed unanimously to award to Mike Beaver Trucking 300 ton of Driving Surface Aggregate (DSA) delivered by 6/18/2010 for \$19.18 a ton totaling \$5754.00; Jefferson Paving Corporation awarded 300 ton 2B delivered by 5/28/2010 for \$18.75 a ton totaling \$5625.00; IA Construction Corporation awarded 800 ton #8 anti skid delivered by 8/20/2010; Jefferson Paving awarded 4000 ton DSA spread for \$21.50 a ton totaling \$86,000.00; Jefferson Paving awarded 7150 square yards of Single Seal applied, weather permitting, by 5/28/2010, for \$1.57 a square yard totaling \$11,225.50 and Jefferson Paving awarded Duhring Road Reconstruction Project for \$116,958.00. Other bids not awarded were as follows: 300 ton DSA Jefferson Paving bid \$19.95 per ton totaling \$5985.00 and Glenn Hawbaker bid \$21.30 per ton totaling \$6390.00; 300 ton 2B Glenn Hawbaker bid \$20.80 per ton totaling \$6240.00 and Mike Beaver Trucking bid \$19.18 per ton totaling \$5754.00; 800 ton #8 anti-skid Jefferson Paving bid \$19.25 per ton totaling \$15,400.00, Glenn Hawbaker bid \$21.30 per ton totaling \$17,040.00 and Mike Beaver Trucking bid \$16.55 per ton totaling \$13,240.00; 4000 ton DSA spread Glenn Hawbaker bid \$26.00 per ton totaling \$104,000.00 and Mike Beaver Trucking bid \$27.00 per ton totaling \$110,000.00; 7150 square yard Single Seal applied Suit Kote bid \$1.729 a square yard totaling \$12,362.35, Russell Standard bid \$2.245 a square yard totaling \$16,051.55 and Glenn Hawbaker bid \$2.06 a square yard totaling \$14,729.00; Duhring Road Reconstruction Project Russell Standard bid \$176,666.00 and Glenn Hawbaker bid \$158,850.00.
